Aims to achieve this goal through a partnership between the accountancy profession (represented by the Pan African Federation of Accountants ("PAFA")), accountants general or their equivalent (currently being represented by the East and Southern African Association of Accountants ("ESAAG" - and soon the African Association of Accountants General "AAAG"), and supreme audit institutions or courts of auditors (represented by the English ("AFROSAI-E") and French ("CREFIAF") language sub-groups of the African Organisation of Supreme Audit Institutions ("AFROSAI")).
